Completed application and payment should be sent to IRI. Fee covers tuition and materials, single guest room, group meals, coffee breaks and receptions during meeting dates. Personal charges such as laundry, dry cleaning, extra room night stays, etc., are payable directly to the Allen Center at checkout. Registration is on a first-come, first-served basis. Accommodations will be made at the Allen Center (on campus) as space permits. If space is not available, accommodations will be provided at a hotel a few blocks from campus. If an applicant is not accepted, full refund of all fees will be made. If a registrant is unable to attend, the fee may be transferred to a substitute. If no qualified substitute can be arranged before May 3, 2019, a refund will be issued, less a \$1,000 non-refundable deposit. Registration cancellation requests must be made in writing and received 4 weeks prior to the meeting. No refunds will be issued for cancellations received after May 3, 2019. Registration may be transferred and is strongly encouraged. Full payment is due May 3, 2019.
